Old Business:

Ramp Twp. Hall (Oct 15th - 30th 2016): Mr. David Rodgers reported to the Supervisor on Nov 7th, it was too late to start the Twp/ Hall ramp project but we will be the 1st in line in the spring when the Schoolcraft County spring load limits are lifted.

New Business:

- 1. Local Historian of the Gulliver Historical Society, Marilyn Fischer presented the Township with a book on the history of the Doyle Twp Hall. Fischer attempted to get the hall put on the list of Historical buildings with the State of Michigan. She was turned down because of the changes made to the hall, such as vinyl siding, and new windows in the front.
