2. Two property tax issues were discussed. They were paid late by the Doyle twp Treasurer. Matter was resolved.
3. While shingling the roof Dehanke Construction company brought to our attention that there is no insulation in the roof of the town hall. Supervisor Nelson asked Dehanke to give us a bid on that job.
4. Lisa Busch of the Schoolcraft County Tourism and Commerce was present and reported on the up coming Community Academy. Which will prepare participants for future roles in serving the non-profit Community in elected or appointed government position and other community programs. 5. A Representative from Schoolcraft Memorial Hospital was on hand to answer questions and report on the arrival of a new CEO Robert Mach starting on August 11 2025.
